Reason for Cancellation:

 - o Contracts with a **remaining tenure of more than one (1) year** shall be **assumed by M/s Hytech Automation on a pro-rata basis**, ensuring continuity of service without disruption.
4. Any **long-term associations or engagements** previously managed by the above partners shall henceforth be **transitioned and managed directly by M/s Hytech Automation**.

Cancellation of Authorization:

Any document, communication, or representation identifying the above-mentioned entities as **authorized distributors, service providers, or channel partners of M/s Hytech Automation** shall be deemed null and void with immediate effect.
